- Overnight Security will be provided Friday and Saturday nights.
- **Exhibitors/Vendors are asked to donate a plant or equivalent art object to the Equality Garden Club (EGC) Member's table for re-sale purposes (recognized as a tax-deductible donation with letter provided).**
- Exhibitors are responsible for collecting and paying Florida Sales Tax.
- Management reserves the right to remove any exhibitors/vendors for any cause deemed inappropriate or not compliant with event rules.
- EGC (lessor) shall have the right to terminate the agreement and refund the fee if, in the lessor's judgement, it is in the best interest of the show.
- No person except security personnel, shall be allowed in the show areas after closing time or more than one hour before the day's sessions opens. No exhibits will be removed until the show closes. **No packing of exhibits until the show closes.** All merchandise remaining after 5:00 p.m. on November 20, 2021 will be removed at the complete risk and expense of the exhibitor/vendor.
- **Payment in full for a booth size and location is required to secure your previous location or location of choice provided it is available.**
